4. Insurance

Currently the HCHNA has no liability insurance. We must have insurance if we wish to use the Chilhowee Club parking lot. A **memo** was sent out last week. There are two quotes:

Morency & Associates of Gallatin, TN at \$400 per year or

 Sammy Sawyer of Oak Ridge, TN at \$305 for the Fall Gathering (Block Party), Luminary build and distribution, and the Progressive Dinner. Other events would be extra.

Both provided sufficient liability limits for the Chilhowee Club. Sammy Sawyer provides higher general liability limits than Morency & Associates.

Discussion: There was a general feeling that a year-long blanket coverage would best meet our needs.

Motion to approve acquiring insurance from Morency & Associates of Gallatin, TN in the amount of \$400 made by Bill, seconded by Wannis carried unanimously

5. Fall Gathering

Expenses:

A. Bounce House

Motion to approve rental of a bounce house from **Harvest Party House** in the amount not to exceed **\$280** made by Jennifer, seconded by **Ann** carried unanimously

- B. Food Truck the food truck, **Pistol Creek Eats**, needs to have a minimum sales of \$500
 Motion to approve payment to **Pistol Creek Eats** to make up for lost sales in an amount not to exceed \$500 made by Chris, seconded by Ann carried unanimously
- C. Postcards these are reminder postcards to the neighborhood. **Motion** to fund mailing postcards to households in the neighborhood in the amount not to exceed **\$200** made by Bill, seconded by Sally carried unanimously
- D. Permits we need permits from the City for the street closure and the food truck. The street closure is free the food truck permit is \$20.00.
 Motion to approve payment of permits for street closure and the food truck in an amount of \$20.00 made by Jennifer, seconded by Bill carried unanimously
- E. Music a band would cost \$500, a DJ might be less.
 Discussion: a DJ at \$150 per hour was recommended with the amount of time weighed. There was a motion for a two-hour time span, then an amended motion with the proposed hours of 1:30 to 4:30 so *Amended* Motion to contract with a DJ in an amount not to exceed \$500 made by Bill, seconded by Heather carried unanimously

6. Mailboxes

There was some concern over the mail delivery in this neighborhood. It was suggested that by putting our mailboxes along the street that service might improve. There was no interest in changing our current delivery system.

7. October Meeting

Schedule luminary build for Sunday, December 18. A list of supplies to order will be presented at the next meeting. We also need more metal buckets to cool the toasted sand. Note: the sand is toasted to make sure that it is dry so as to not weaken the luminary bag.
